  - o Simplistic summary still at 52% complete
- Ed requested that Will Lyons attend the Platform TCK meeting, but I have a conflict
  - It looks like Web profile and Platform TCKs cannot be completed in the next five weeks.

## October 22 Update

  - o Done 19 (up from 16)
  - In review 1 (no change)
  - o In progress 8 (down from 11)
  - Ready to assign 3 (no change)
  - Simplistic summary 61% complete
- We discussed Ed Burns' mail to the Platform team, the TCK dev team, the Spec Committee and Steering Committee on Oct 22 just prior to the SC meeting:
  - o Ed revived one of the "put aside" proposals from the Platform TCK Team.
    - For discussion let's call this the "10 + 11" proposal.
    - To be a ratifying compatible implementation of the Jakarta EE 11 Platform and Web Profiles, an implementation must:
      - Pass the Jakarta EE 11 Platform TCK according to the "11 with exclusions" proposal.
      - Pass the off-the-shelf Jakarta EE 10 Platform TCK, but with a well-defined set of exclusions, as defined by the Jakarta EE Platform Project team and TCKteam.
  - Ed took away the following list of suggested changes [this is a cut and paste of his subsequent mail on Oct 22]:
    - Remove "ratifying" from "ratifying compatible implementation".
    - Clearly commit to producing an EE 11 TCK that does not have this hybrid approach.
    - Do not overload the term "EE 11 TCK".
      - Instead, define the EE 11 TCK as
      - "11 with exclusions" and "10 with a different set of exclusions"

# **CY2025 Program Planning**

- The Eclipse Foundation has provided calendar guidance for CY2025 Program Planning
- The process for CY2025 Working Group program planning should begin during September
- Folder with the 2025 planning files
- Notes from October 15 meeting
  - Some comments on the Retrospective and the Program Planning process prior to today's discussion:
    - Thanks to those who have provided comments in the Comments for Retrospective 2024 Jakarta EE Program Plan. It is useful to capture perspectives on performance vs. the CY2024 Plan as part of the CY2025 Planning process. Having started this process, we should complete it.
    - Please bear in mind the schedule on slide 13 of the <u>2025 Program Plan</u> Process deck. We need a Draft Program Plan approved by late October.
    - It has not been a goal of the annual Planning Process to define specifics of future Jakarta EE release content or schedules. Requirements to resolve such questions as part of the CY2025 Planning Process would need to have been raised months ago and were not. Such questions, IMO, are not resolvable, at this time, within CY2025 Planning Process timelines.
    - This is not to say that such issues should not be raised. For issues, such as the above, that are not susceptible to resolution (IMO) during the CY2025 Program Planning schedule, I believe that we should identify, as part of our Program Plan, goals to resolve these issues in specific timeframes, and/or through specific processes. In the case of Jakarta EE release plans, the Jakarta EE Future Directions Interest Group offers a natural process for such discussions, and we should use it.
    - I think Kenji has made valid comments about the slip in Jakarta EE 11.

      Although Platform TCK refactoring is a one-time event, we should have a goal related to release process improvement to better identify and manage release risks.
  - The above comments from Will Lyons were reviewed
  - The review and discussion of CY2024 goals was completed
    - All members were invited to capture their comments directly in <u>Comments</u> for <u>Retrospective - 2024 Jakarta EE Program Plan</u>
    - There was insufficient time to recap the discussion the following comments are intended to summarize the discussion:

- There was general consensus that we should reduce the number of strategic goals, and apply more focus and direction to the primary goals, such as:
  - Deliver Future Jakarta EE Specification Releases
  - o Increase Jakarta EE Brand Awareness & Adoption
  - Grow Contributors and Reward Committers
  - Grow Working Group Membership
- There remains a difference in perspective on the degree to which the Steering Committee should attempt to define, as part of the CY2025 Program Planning Process by early November, the content of future Jakarta EE releases within the goal "Deliver Future Jakarta EE Specification Releases"
  - Will Lyons offered to draft CY2025 goals that he believes would help form consensus from Committee on the CY2025 plan
    - This would not include the content of future Jakarta EE releases
  - Reza Rahman offered to draft more specific goals wrt to the content of future Jakarta EE releases
    - If there were committee consensus on these goals they could be included in the CY2025 plan
- Notes from Oct 22 meeting
  - We reviewed DRAFT CY2025 slides, drafted by Will Lyons, consistent with the above discussion

    - Slide 21 Align Jakarta EE with Developer and Business Needs
    - Slide 23 Grow Working Group Membership
  - There was general consensus on the above, specifically:
    - Dropping the goals with strikethroughs
    - Slide 11 Deliver Future Jakarta EE Specification Releases
      - Will's draft slide defers to Q1 providing specific EE12 direction
      - Reza will pursue defining EE12 direction in the Program Plan itself
      - If Reza builds consensus in time we can adopt that consensus
      - Otherwise we will drop to approach suggested by WIII
    - Slide 13 Increase Jakarta EE Brand Awareness & Adoption
      - Awaiting input from Marketing Committee
    - Slide 17 Grow Contributors and Reward Committers
