## **Updated Licenses**

- Received email on Oct 23.
- The Eclipse Foundation Board of Directors recently approved new versions of the <u>Eclipse Foundation Specification License</u> and the <u>Eclipse Foundation TCK License</u>.

The only material change to either license is to update the license to indicate the license is granted by Eclipse Foundation AISBL, our Belgian organization, rather than Eclipse.org Foundation, Inc., our original US-based organization. This update is part of our ongoing transition to being a European organization.

There is no action required by the working group governance. Rather, this note is simply for informational purposes. No existing specifications are required to take any action, though each specification project is welcome to do a maintenance release to enable publication using the updated licenses should they choose. We will, however, begin insisting that both new specifications as well as new versions of existing specifications (other than service releases), to use the new versions of the licenses.

In addition, over the coming weeks we will reach out to each of the members that have previously executed Compatibility Trademark License Agreements (e.g. Jakarta EE, Sparkplug) to notify them of the change and to formally amend them accordingly. This is required as these license agreements make explicit reference to the versions of each of Specification and TCK licenses, and thus is treated as an amendment.

We have communicated and agreed with Devnexus 2024 organizers to have a Jakarta EE Track again. As you may know the official CFP for the conference is closed already. For this reason, we will change the submission approach this year and simplify it, keeping in mind that we will need only 9 talks!

Considering our members have great speakers with equally great talks, we will collect members' desired talks first and then determine if more talks are required from the community. There are a number of speakers in our broader Jakarta EE community that we can reach out to but would like to fill the track from the working group. If some of your speakers have already submitted Jakarta EE related talk, that you think should be on the track, please check with them if they would consider switching the track.

My ask for all of you on the marketing committee is to provide one speaker name and talk title/abstract from your organization that you, as a member, believe would help us deliver a compelling Jakarta EE Track at Devnexus 2024. Once we have our talk selection complete we will work with the organizers to have it published on the website.

Our goal is to have our final list of talks by early November, so please respond to the email with your speaker and the talk by Tuesday October 24th.

This will leave us time to focus on promotion of the talks so we can attract as many attendees as possible to the Jakarta EE Track.
